PRIVACY INFORMATION RELEASE

This document is provided for the 13 art. of the n.° 196/2003 Legislative Decree - Private Personal Data Ordinance.

PERSONAL DATA TRUSTEE

As a result of the establishment of professional relations directly or indirectly connected with our institutional activities, we are allowed to use personal data relating to identified or identifiable people. In this case, the personal data trustee is **A.S.DILETTANTISTICA S.C.STELLA ALPINA**, whose registered office is located at #39, Leonardo da Vinci Street, Gardone Val Trompia, ZIP 25063.

PLACE OF PERSONAL DATA USAGE

Private personal data must be used and cured by the S.C.STELLA ALPINA staff inside the registered office and, in case of necessity, by occasional officers. Private personal data must be used in order to carry out the required professional service. In case of real necessity - that is, as a result of activities indirectly connected with the one of S.C.STELLA ALPINA - they are allowed to be forwarded to third parties. In a situation like this, S.C.STELLA ALPINA is obliged to ask for permission to the interested parties.

PRIVATE PERSONAL DATA TIPOLOGY

Personal data: for the best accomplishment of its professional activities, S.C.STELLA ALPINA is unequivocally authorized to use the data supplied with the agreement signature. Likewise, S.C.STELLA ALPINA is implicitly authorized to convey the private data to third parties, when this might result to be required for the best accomplishment of the charged assignment.

Internet navigation data: during their normal course, the informatics systems and the software procedures - that is the base of our web-site working - acquire the personal data implicitly transmitted during the work of internet protocol. These data are not information collected in order to be associated to definite and particular people. Nevertheless, for their own nature, they might lead to the identification of the subscriber through elaborations and associations with data held by third parties. This data typology includes IP addresses and domain names of the personal computers used by the subscriber to connect with, URI (Uniform Resource Identifier), the requested time, the method used to submit the request to the server, the file answered size, the numerical code showing the state of the server answer, (ok, error,...), other parameters connected with the operating system and the informatics background of the subscriber. These data must be used only in order to obtain anonymous statistical information about the use of the site and to control the proper work. They must be deleted immediately after the elaboration. Personal data might be used to check the responsibility in case of hypothetical informatics offences to the prejudice of the website. Except for this contingency, informatics data are automatically deleted after 30 days.

Data given of subscriber's own will: sending optionally, explicitly and voluntarily e-mails to our internet address implies the subsequent acquisition of the subscriber's address - needed for answering to his requests - and the other private data inserted in the e-mail. More precise and summarized information will be progressively reported or displayed on our website pages beforehand for particular services by request.

COOKIES

No datum of the subscriber is obtained by the website deliberately. Cookies must not be used in order to send personal information. Furthermore, we do not use any type of persistent cookies, namely systems for the subscriber tracing. The usage of session cookies -that are not stored in a persisting way on the personal computer of the subscriber and vanish when the browser is closed- must be strictly limited to the transmission of the session usernames, constituted by random numbers generated by the server, necessary to consent the safe and efficient exploration of the website. The session cookies might be used by our site avoid their resort to other informatics techniques potentially detrimental to the privacy of the subscriber's navigation. Furthermore, they do not allow the acquisition of personal data useful for the subscriber's identification.

OPTIONAL CHARACTER OF THE DATA UNDERWRITING

Except for what specified with regard to the navigation data, the subscriber is free to give his own data reported on the contractual form and on every other form arranged by S.C.STELLA ALPINA. The non-underwriting of the personal data can involve the inability to obtain what wanted.

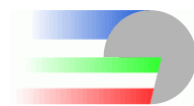
RIGHTS OF THE SUBSCRIBER
